

ARTIFICIAL INTELLIGENCE POLICY FOR STUDENTS

Al Technology

This policy is about using Artificial Intelligence, or AI for short. Think of AI as clever computer programs that can do things that seem like human thinking.

Because these smart tools are becoming more common, we want to make sure everyone understands how we will use them at school and how you, as pupils, can use them too, especially for your school work.

How Our Teachers and Staff Use Al

Our teachers and staff are allowed to use AI tools to help them with their job in smart and safe ways. They will always follow our rules when they use these tools.

Here are some ways teachers/staff might use AI:

- To help plan lessons
- To find information for research
- To get ideas for new projects
- To write drafts of notes or presentations
- To help with computer coding
- To get quick summaries of information

Some of the AI tools our teachers/staff might use are:

- Gemini (Google AI)
- Starryai.com (to create Al images)
- Openai.com (ChatGPT)
- Claude.ai
- Copilot.microsoft.com (Microsoft AI)

We might add new tools to this list, so it could change.

How Pupils Can Use Al

Here are some ways you are allowed to use AI for your school work:

- As a tool to help you find information (like a smart search engine)
- To help you come up with ideas for your projects
- For homework or classwork, but only whilst following the rules as set out below

Important: You can only use AI tools if your teacher says it is allowed, especially for exams or coursework. If your teacher has not given permission, you should not use AI to help with your work.

What's NOT allowed with AI (AI Misuse)

It is important that your school work is *your* own work. Using AI in the wrong way could be seen as 'cheating'.

Here are some things that are **NOT allowed** when using Al:

- Copying or rewording what the AI creates and presenting it as your own ideas.
- Copying or rewording *whole answers* from the Al.
- Using AI to do parts of your work (like calculations or writing) so it does not show *your* own understanding.
- Trying to hide that you used AI, or giving wrong information about it.

Always Remember to Give Credit

If you use an Al tool to find information for your school work, you **must** tell us where you got it, just like you would with a book or a website. You need to say which Al tool you used (such as "Gemini" or "ChatGPT") and the date you got the information from it.

Privacy and Your Information

We do not put your personal data into any Al applications. If we ever needed to in future, we will tell you and your parents about it and update this policy.
